### 4. Other

Every document in a foreign language must be translated into Serbian, certified by a court interpreter.

A separate application is submitted for each locomotive.

Upon opening the bids, the commission determines the completeness of the documentation and determines who has fulfilled the conditions and acquired the right to participate in the public auction. Prospective buyers who have met the requirements compete publicly and orraly.

Each step of public bidding cannot be lower than 5000 EUR.

- The right to conclude a sales contract is acquired by the bidder who offer (bids) the highest price for the electric locomotive. The deposit paid in the name of participation in the auction is retained by the Seller upon signing the contract with the Buyer
- as a mean of security for performance bond.

  Handover of decommissioned electric locomotives to the Buyer will be performed on the basis of a written handover at the
- locations specified in the text of the advertisement.
- The Contract on the purchase and sale of decommissioned electric locomotives between JSC Srbijavoz, Belgrade and the Buyer will be concluded within '15 days from the day of the auction
- The buyer will pay the price achieved at the auction:
  - 100% advance payment for the individual taking over of the electric locomotive
  - The advance payment is made within 60 days from the date of issuing the proforma invoice.
- A bidder who has bid but has not concluded a contract or does not perform advance payment in the amount of the purchase and sell price is not entitled to a refund of the deposit.
- In the case that advance payment is not performed, within the stipulated period, the Sale Contract is terminated, and deposit is retained without the right to be refunded.
- After the performed payment stipulated in the Agreement, the Buyer will take over the electric locomotive no later than within 90 days from the day of the payment. In case of failure to take over the electric locomotive within the specified period, JSC Srbijavoz will activate the means of
- financial security for performance bond.
